#### Rev. Martha Clark

As of this week, The Rev. Martha Clark has been licensed to do Supply Ministry in the Diocese of Virginia, and specifically with the congregation of Good Shepherd.

A graduate of Harvard University (1982) and the Duke Divinity School (1992), Martha spent almost 30 years of ministry in multicultural congregations as well as small church and mission settings. Her ministry has taken her both overseas (Mozambique, Kenya, Switzerland) as well as more locally (Maryland, DC.)

She most recently served as Rector at St. Augustine's Episcopal Church in the Diocese of Washington from 2005 until her retirement in 2019. Martha and her husband, Bryan Zidek, along with their teenage daughter, Sophia, moved to Lincoln, VA just a year and a half ago and are getting to know the area, enjoying new friends and neighbors.

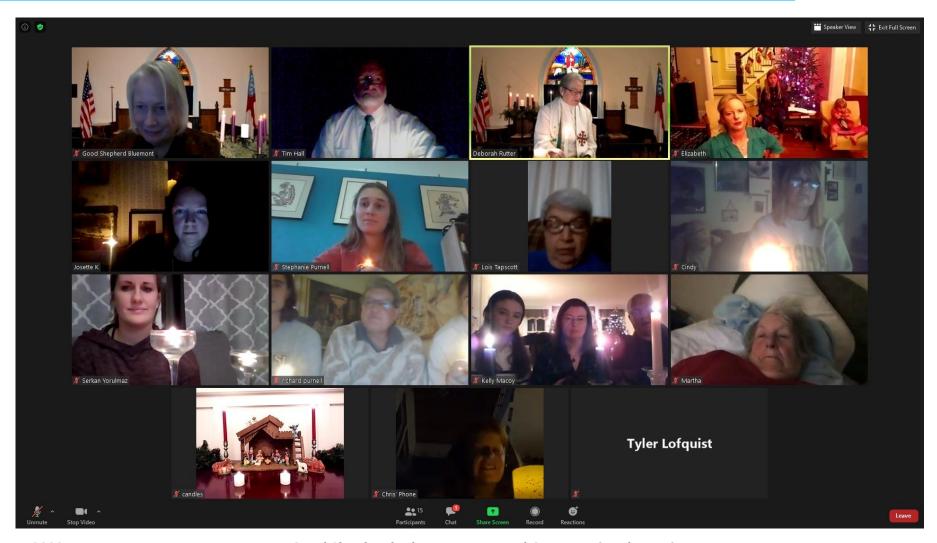

  - 2021 Scott Foundation grant for \$3,500 for Church painting and repairs (and \$10k in 2020)
  - 2022 Peter J. Lee Small Church Revitalization Grant request for \$4,000 for Prayer and Meditation Garden

- Discipleship and Spirituality
  - Epiphany Series zoom meetings Lead by Rev. Deborah Rutter
     The Book of Joy: Lasting Happiness in a Changing World 18-20 people attending this 4-week study. 4-5 of these are folks from outside of Good Shepherd.
  - Lenten Series zoom meetings Topic TBD
- Vibrancy and Sustainability
  - Creation of a Prayer & Meditation Garden on the east slope of the church. The garden will
    focus on erosion control with native, non-invasive plantings and pollinators to provide a
    space for worship and prayer. The goal is to provide a welcoming space near the chapel and
    Stations of the Cross pathway.
- Proclaiming Good News and Serving the Community
  - Spiritual Walks with a Priest to provide an opportunity to serve those in and outside of our congregation
  - Open our church to small groups as we do for our local AA.

### **Facility**



- Overview
- Maintenance
  - Cleaning, insect control, lawn care, snow removal, patio power washing, HVAC
  - This continues to be (rightfully so) a major part of our operating budget
- Improvements
  - Plumbing upgrades in our bathrooms
  - Installation of an internet hot spot
  - Electrical work to include new inside and outside outlets and parking lot lighting
  - Parish Hall ceiling painting, installation of gutter guards
  - Purchase of hybrid service support equipment (laptop, webcam, Yeti microphone)
- Going Forward in 2022
  - Prayer & Meditation Garden (applying for partial coverage by Peter J. Lee Small Church Revitalization grant)
  - Expand hybrid service capabilities
  - Repair or replace church sign / new mail box / other landscaping
  - Apply for historic property / landmark status
  - Interior painting, sacristy storm windows, and other routine maintenance
